3. This promotion is only valid on direct from manufacturer new products or A-Grade products sourced as in Clause 2. Refurbished machines, second-hand machines, any machine acquired from commercial leasing, hire purchase, URN supported business or similar arrangements and any machines sourced via the internet from a company not registered in the United Kingdom do not qualify.
